## McHenry County Mental Health Board

Fiscal Year 2024 began very hopefully with a slight increase in the property tax levy of \$525,000. A countywide referendum was passed by the voters to change the funding source from a property tax levy to a sales tax levy; unfortunately, the Mental Health Board is not receiving additional revenue as expected.

As many of you may be aware, since the 1967 voter referendum, per the Community Mental Health Act, the MCMHB has received a property tax levy to fund Mental Health, Substance Use Disorder, and Intellectual/ Developmental Disability services. Our collaboration with the County Board led to an increase in a property tax levy of \$525,00 for FY24 and a decision to implement a voter referendum in March 2024 to switch us to a sales tax levy; this initiative was forecasted to generate higher revenue. The voters narrowly passed this referendum in March. However, when we received our first sales tax revenue disbursement in October 2024, we found the revenue from sales tax to be significantly lower than projected. FY2024 was a bit of a rollercoaster with many highs and lows causing us to use some of our fund balance to keep the budget flat relative to the previous year. Budget determinations are expected to pose a challenge for FY2025.

We had funding alignments surrounding youth services for example which reflect our commitment to prioritizing our strategic initiatives in our community. The Mental Health Board funded grant writers and secured over \$3.1M in total grants in 2024. From that total the 22nd Judicial Specialty Courts was the recipient of the majority of the grants awarded receiving just over \$2.9M in grants. One of the grants is for a project aligned with our strategic planning efforts around the Severely Mentally Ill (SMI) population and the opportunity for those who qualify for outpatient treatment. This project would create additional options

for Assisted Outpatient Treatment (AOT). Such treatment options help individuals who have experienced psychiatric hospitalization remain stable within the community, creating a better quality of life as well as reducing costs associated with hospitalization. We are very excited about setting up a future program in our community. The MHB hosted AOT meetings in conjunction with supporting the grant writing effort with a commitment from stakeholders that we'd continue on this path. Implementation will occur in 2025. Other areas of progress have been in our Trauma Informed work, No Wrong Door Approach, and with our Next Day appointment initiatives noted on pages 10 and 11 and many more! We are also very excited that our local Thresholds is in a Certified Community Behavioral Health Clinic (CCBHC) demonstration project. In addition, we were able to partially fund Clearbrook CILA in Woodstock, provide more resources for schools, increase training opportunities, and increase community awareness. More to come in 2025. Please see all the highlighted accomplishments on pages 6 and 7.

In conclusion, the accomplishments of FY24 reflect our commitment to enhancing and expanding mental health, substance use, and intellectual/developmental disability services across McHenry County. We remain dedicated to advocating for the resources necessary to meet the service demands of our community while ensuring our providers can deliver the essential services our residents rely on. We want continued feedback on community needs, which can be gathered in public comments at our monthly Board meetings, email, or attending our yearly townhall in May. We look forward to serving the needs of McHenry County.

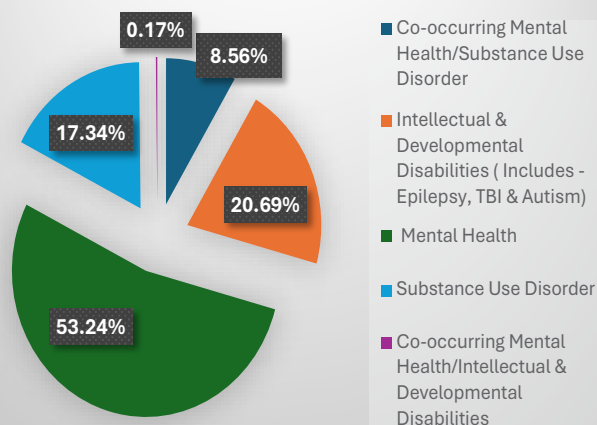

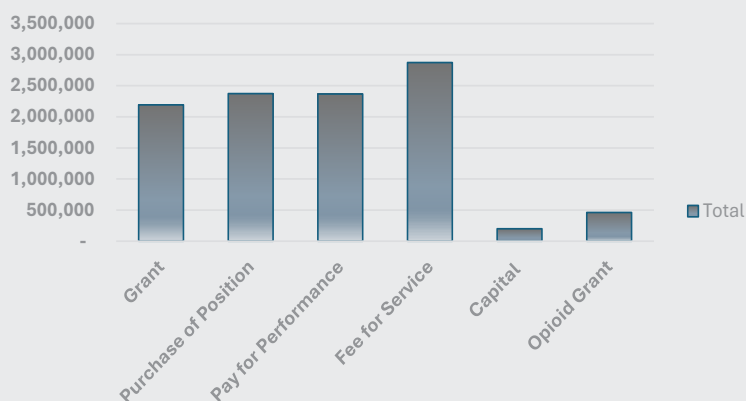

## FUNDING TYPES

### Fee-for-Service (FFS)

Payments for each event of service. When possible, rates are based on those set by the State of Illinois.

### Standard Grant (GRANT)

Provides funds for access to specific care or the infrastructure of a program and requires year-end reconciliation of actual expenses.

### Pay-for-Performance Grant (P4P)

Payment is predicated on the reporting MHB defined output and outcome data. Pay-for-Performance Grants primarily support access to Psychiatric/Prescriber services.

### Purchase of Position (POP)

Payment for a particular staff position critical to the delivery of an approved service or program for which Fee-for-Service funding is not applicable.

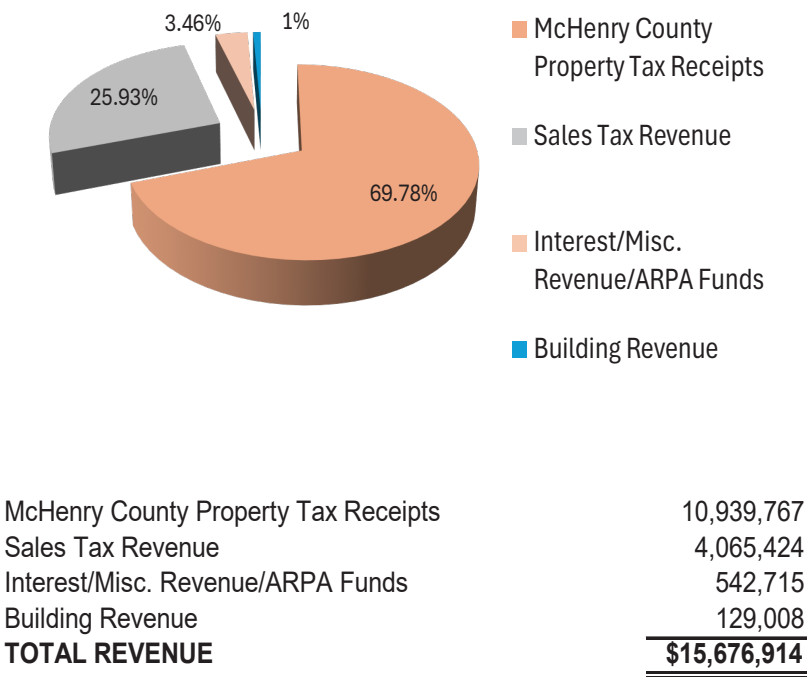

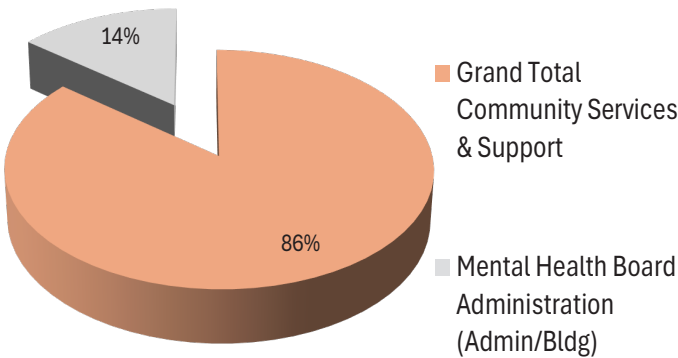

# MCMHB FY24 Strategic Plan

## Accomplishments

- Funding Alignments: New funding alignments with priorities achieved such as: partial funding for Clearbrook CILA in Woodstock; Clinical Navigator position focused on children and adolescents - a resource for schools; Child and Adolescent psychiatrist; SUD Recovery assistance through Social Isolation Program; SUD Student Assistance Program for schools; Autism Day Program; BH Scholarships for group homes (through warrant of need); URS Pilot program to support for increased resources to those presenting to Homeless Shelter overnight; Child and Adolescent Community Support Team start-up; Teen Prevention Program; and Street Outreach Program.
  - FY24 MHB investment in new C&A services - SAP, Child Psychiatrist, Clinical Navigator, CST, & SAP
  - Increased Funding: Secured additional PoP and grant funding to support workforce initiatives.
  - CCBHC Initiation: Thresholds Certified Community Behavioral Health Clinic began operations in Illinois on October 1, 2024.
  - Advocacy Efforts: Promoted legislative awareness and education across the Network, collaborating with associations on disability-related policymaking.
  - Provider Certification: A Network provider received SUPR certification.
  - Expanded Services: Increased Switz line use for translation; two providers expanded services to Harvard area.
  - Trauma-Informed Initiatives: via contracted professional: Chaired the monthly Trauma-Informed Change Team; Held a bi-monthly support group for direct service providers;
- Developed a collaborative two-hour training for School Professionals to meet their state requirement training; Developed a one-hour version of the new Trauma-Informed presentation; Began work on a short Trauma-Informed video & accompanying booklet for support staff to roll out in FY25; Continuing to evaluate the “Handle with Care” pilot in McHenry and introduced “Handle with Care” team to new District 15 Assistant Director of Learning Services, and others; Created grade-level Trauma-Informed instructional handouts for school resource fair; and led and facilitated a successful World Trauma Day 2024 event at MHB.
- Training Increase: MHB hosted 54 trainings with 2,658 attendees, along with 63 QPR sessions (2,329 trained) and 16 MHFA sessions (184 trained) supported through NAMI.
  - Crisis Line Transition: Local Crisis Line moved to the 9-8-8 number.
  - Bell Seal Achievement: Supported programming leading to County's Platinum Level Bell Seal for Workplace Mental Health, partnering for future trainings.
  - Revenue – Levy/Grant Success: Awarded over \$3M in grants for providers; facilitated \$525,000 levy increase in FY24 and shift from Property Tax to Sales Tax will be evaluated.
  - Community Awareness: In line with the strategic initiative to increase awareness and visibility of community resources, a partnership with the NW Herald was developed to produce monthly articles designed to increase awareness on relevant topics and promote the resources available to our community. Additional community awareness

successes include the MCMHB being featured in the Northwest Quarterly Magazine Winter (2024) edition; MCMHB-promoted resources, including our Town Hall, were included in a 12-page insert flyer in the NW Herald's April 2024 publication. The MCMHB secured a commitment from the Crystal Lake Chamber of Commerce to have Mental Health in the Workplace as their May topic in the CL Chamber Connection publication. The MCMHB also reached out to 88 local libraries, park districts, townships, city halls, and legislatures with McHelp sample flyers, bookmarks, and window clings, encouraging these entities to place the McHelp App on their websites to further expand community awareness of this available resource. FY24 community awareness efforts also included ongoing radio spots; a form placed on MCMHB's website for requests from businesses and the community for onsite presentation topics from the Network; and the annual School Resource Fair was successfully implemented.

- Intake Coordination: Reintroduced the "No Wrong Door" philosophy and created a directory for warm referrals.

- AOT Steering Committee: Fostered commitment towards \$1.6M SAMHSA grant for Specialty Courts to implement an AOT program in McHenry County.
- Next-Day Appointments: Expanded walk-in services for urgent cases; many providers now able to offer next-day intake appointments, including services for children regardless of payment ability.
- Outcome Standardization: MHB Ethics and Compliance Committee with provider inputs recommended outcome standardization changes for FY25.
- Suicide Prevention Task Force: Completed a strategic plan focused on education, outreach, advocacy, and coalition building.
- Substance Awareness Coalition: Active re-engagement of membership.
- Decreased Death Statistics: Noted 35 deaths by suicide in 2024, and 39 deaths by overdose with increased Naloxone distribution (7,440 doses) this past year by Live4Lali alone.

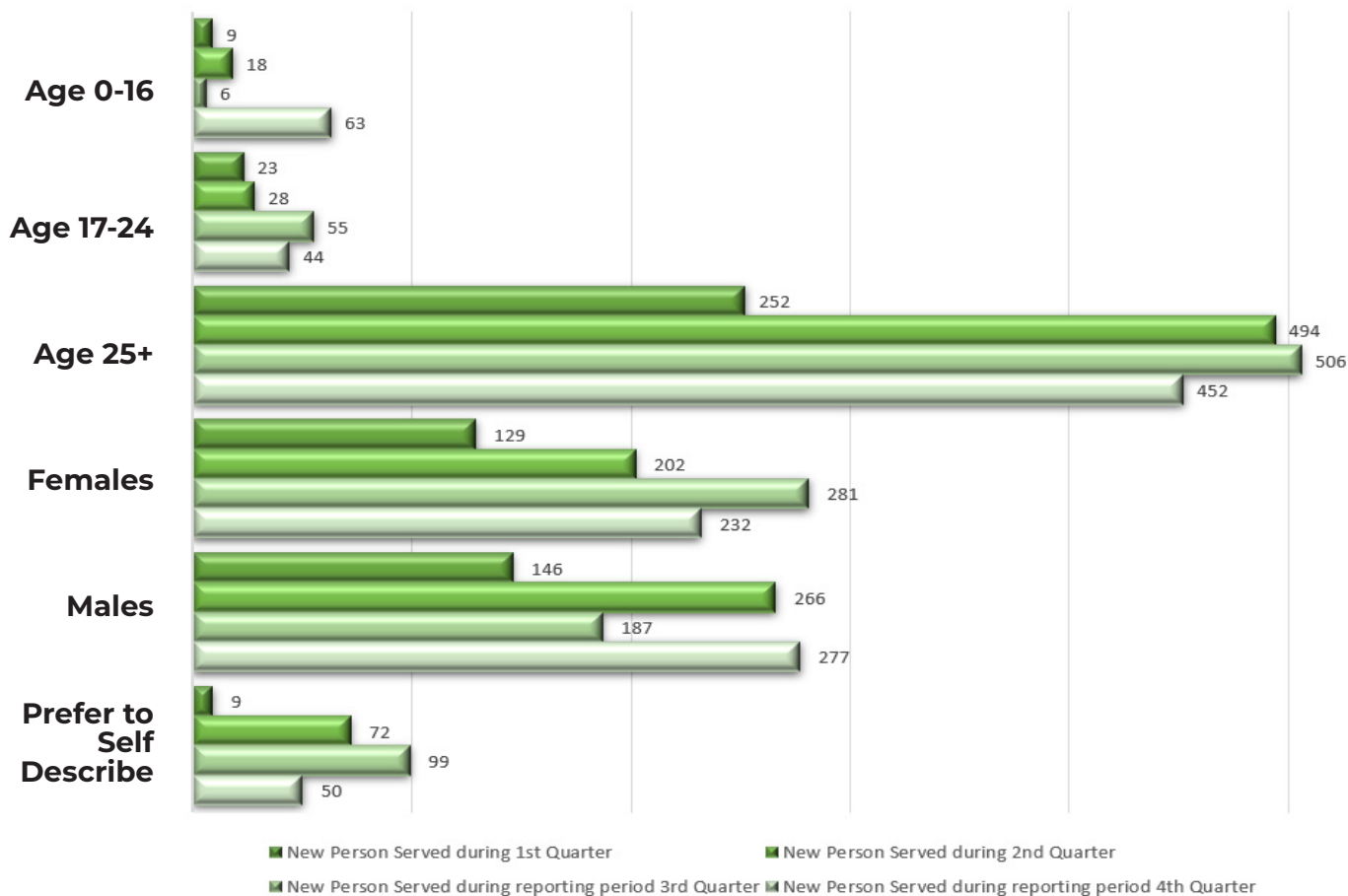
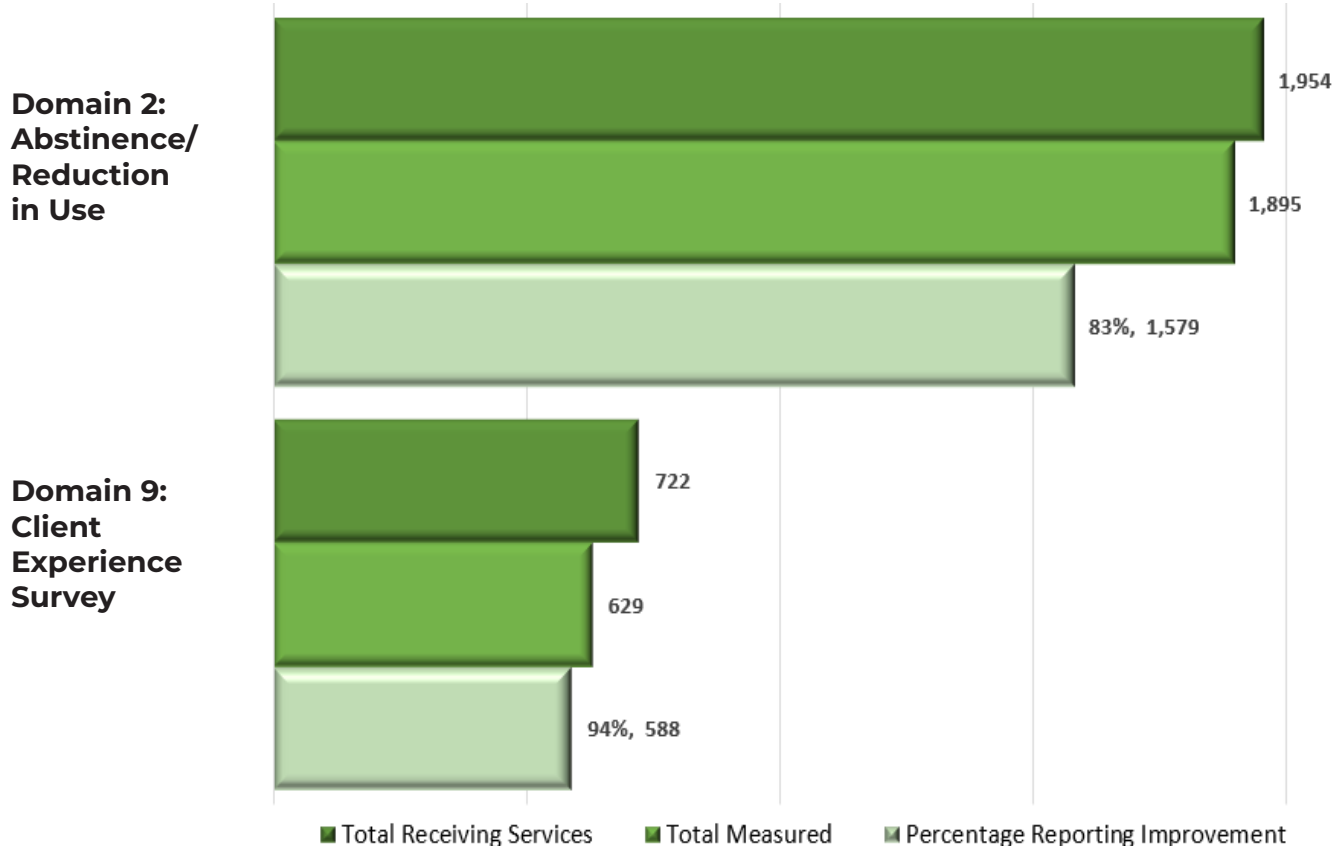


## McHenry County Mental Health Board Domain 8 Access/Capacity

# Immediate Next-Day Intake Appointments for Treatment

**Rosecrance:** Daily M-F immediate walk-in intake appointments **8 am - 3 pm** at their Dakota Street Clinic - 620 Dakota St, Crystal Lake, IL for all ages for those seeking mental health and substance use disorder treatment. One entry point for all services provided. **815-528-9307**



Rosecrance has comprehensive behavioral health & addiction treatment services with many levels of care and 3 locations/services overall in McHenry County. Rosecrance Crystal Lake levels of care and support include behavioral health screenings, therapy, intensive outpatient program (IOP), psychiatric services and Medication Assisted Treatment and Medication Management, and crisis services. Rosecrance Dakota levels of care and support include behavioral health screenings, therapy, crisis services, psychiatric and medication treatment, and case management services. Rosecrance Dakota also offers specialty services such as Youth Community Support Team (CST) and a youth Partial Hospitalization Program (PHP). Rosecrance Woodstock Recovery Home (e.g two neighboring duplexes) is a sober living program where adults in early recovery from substance use disorders focus on developing essential skills necessary to maintain lasting recovery.

**Northern Illinois Recovery Center:** Daily M-F immediate walk-in intake appointments for both adults and youth experiencing substance use and addiction issues. For the adult detox center: admissions line 24/7 **(815-515-2029)** which can perform intake screenings every day of the week between **7 am - 9 pm** and take walk-ins at the center located at 620 N State Route 31 in Crystal Lake. Outpatient substance use disorder therapy including PHP/IOP programs: walk-in intake appointments M-F from **8 am - 4 pm** at the 620 N State Route 31 building. **815-515-2029**



**Northern Illinois**  
RECOVERY CENTER

All of NIRC services are located in Crystal Lake, IL, and they have JAHCO-accredited programs that offer detox, residential, PHP, IOP, outpatient, and aftercare for addiction and mental health primarily for adults. Personalized treatment programs such as Drug/Alcohol Rehab, Women's Treatment, Men's Treatment, and Dual Diagnosis. IOP and outpatient treatment for adolescents are also offered along with a Student Assistance Program for McHenry County schools/students. They have two main locations. The Northern Illinois Recovery Center that offers a drug and alcohol detox program to help individuals with the dangerous withdrawal symptoms associated with quitting substance abuse, is located in Crystal Lake on Rt 176. Their outpatient services are also located in Crystal Lake, but on Rt 31. NIRC also has recovery homes in our county for after-care sober living arrangements.

# Immediate Next-Day Intake Appointments for Treatment

**Thresholds - McHenry:** Immediate walk-in intakes for mental health, substance use or even co-occurring medical issues on Tuesdays **9am-1pm** at 2030 N. Seminary in Woodstock for anyone 13 years of age or older. They will be moving to daily walk-in services in the near future. They do have urgent time slots for high-risk cases daily. **815-338-8324**



As our only **Certified Community Behavioral Health Clinic** (CCBHC) in McHenry County (also involved in the state's CCBHC demonstration project), Thresholds provides innovative behavioral and primary healthcare that promotes empowerment, well-being, and full participation in community life. Thresholds provides a wide array of services for individuals with mental health and substance use conditions such as individual and group therapy, care coordination and case management, psychosocial rehabilitation including assertive community treatment (ACT) and community support team (CST), peer support services, primary care integration, and crisis services.

Note: MHB funding is available for these services for those who do not have the ability to pay. Also, Our FQHC's are able to do immediate intakes for integrated care including therapy/psychiatry appointments – **Aunt Martha's-Woodstock** (877-692-8686), **Greater Family Health – McHenry** (815-363-9900), and **Community Health Partnership – Harvard** (815-943-4339) along with our **Family Health Partnership Clinic – Crystal Lake** (779-220-9300).

Integrated health care is a comprehensive and coordinated approach to delivering healthcare services that focus on the seamless integration of various medical, behavioral, and social services to improve patient outcomes and overall well-being.

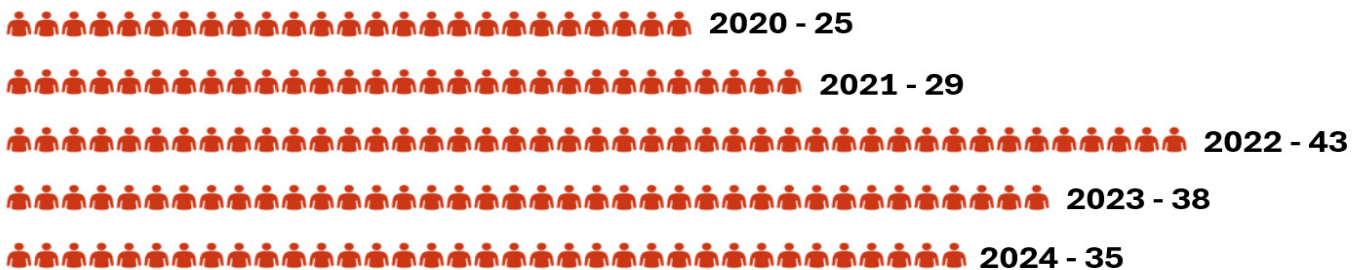

## McHenry County Mental Health Board Network Milestones

- FY 2024 QPR Trainings: 63 Trainings & 2,329 Attendee/Gatekeepers. The increase in gatekeepers is **7% greater** than last FY. NAMI McHenry County facilitates QPR instructors and classes.
- Live4Lali: Naloxone, an Opioid reversal drug that, when available, is administered to someone experiencing an overdose. 7,440 doses distributed by Live4Lali to Community Members & First Responders. This number distributed is **15% more** than last FY as other organizations and pharmacies are involved in distribution and education.
- New Directions - A Way Out Program: Offers access to substance use treatment and resources through law enforcement officers/agencies and 24/7 hotline. In 2024 – 996 participants were helped to gain information and access to drug/alcohol treatment. Call the 24/7 line at (815)347-0385 if you or a loved one need addiction treatment services.

# A Trauma Informed Approach

## Trauma-Informed Change Team: Annual Highlights

### Ongoing Activities:

- Community Collaboration: The Trauma-Informed Change Team actively engages with community leaders, school personnel, and other stakeholders to promote and implement trauma-informed practices across the community.
- Care Provider Support: A bi-monthly support group for care providers is facilitated, meeting on the second Wednesday at noon and the second Thursday at 5 PM.
- Monthly Trauma-Informed Approach Training: Consistent monthly training sessions on “A Trauma-Informed Approach” were conducted, reaching over 300 individuals.

### Key Achievements:

- Held a “Train-the-Trainer” event on Trauma Informed Awareness Day, equipping key Trauma-Informed Change Team members to expand the reach of trauma-informed care principles. | May 2024
- Developed a two-hour video training program, “A Trauma-Informed Approach in Schools,” to meet new Illinois requirements. This was implemented in District 47 (Crystal Lake) and District 15 (McHenry). | Summer 2024
- For the Community Connections Summit: Addressing the Loneliness Epidemic, the team created and distributed a booklet on the loneliness epidemic to 300 attendees. | September 2024
- Conducted a day-long training, “Kintsugi & Healing from Trauma: Adapting the lessons of Kintsugi to Trauma Informed Care,” educating over 60 clinicians on trauma-informed care and specific intervention strategies. | October 2024
- Throughout the Year: Implemented a “Handle with Care” program in McHenry, enhancing communication between the police department and schools. This program serves as a model for other jurisdictions within the county.



## About

# McHenry County Mental Health Board

The McHenry County Mental Health Board (MCMHB) is a special unit of government under the Community Mental Health Act (CMHA) 405 ILCS 20. As a result of Illinois House Bill 708, in 1967 voters in McHenry County established a community Mental Health Board and chose to levy an annual tax for the purpose “...of providing community mental health facilities and services, including facilities for the developmentally disabled and the substance abuser.”

Following this successful referendum, the county government appointed a board of community representatives to administer the mental health fund and to carry out the duties and responsibilities of the Community Mental Health Act. The Community Mental Health Board held its first meeting shortly thereafter and quickly began to develop general operating procedures and to fund agencies.

### **The Illinois Community Mental Health Act mandates Community Mental Health Boards in the State to:**

- Review and evaluate community mental health services and facilities.
- Plan for programs of community mental health services and facilities.
- Consult with others regarding the most efficient delivery of services.
- Appropriate funds to maintain mental health services and facilities.

The Board is mandated to assure on behalf of the community that those in need of mental health, intellectual/developmental disability, or substance use services will have those services available to them. To accomplish this task the Board must continuously engage in policy development focused on their governance of all access, quality, and cost concerns for their constituencies needs.

To carry out these responsibilities board members must provide leadership and vision for the behavioral healthcare needs of county residents. Each board member is accountable to the community. As part of a governing body, each board member must determine what is in the best interest of the community and each of its residents.

In March 2024, a voter referendum moved the MCMHB from property taxes to sales tax (e.g. Special Retail Tax in 55 ILCS 5 of Counties Code). 55 ILCS 5/5-1006.5 is the enabling legislation for sales tax and gives authority to a mental health board and connects the function of said mental health board to CMHA. The CMHA is the enabling legislation that gives authority to a mental health board and outlines the functions as noted above.
